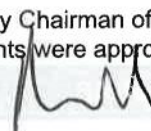

Following an actuarial valuation exercise a surplus amount applied each month in 19/20 changed to a deficit amount in 20/21 which meant the Pension payments increased across the two years from £1280 to £4120 an increase of £2840. The remaining difference is the statutory Local Government pay increase of 2.75% for the Clerk plus a performance increase from SCP 26 to 27 which is equal to 2.9%.
